DAIRY NEWS OF INTEREST

Market Update

Cheddar cheese barrels fell 14 cents to \$1.87 on 9 loads traded, and blocks picked up 3.5 cents to \$1.96 on 5 loads traded. The block barrel spread grew to 9 cents. Butter was up 3.5 cents to \$2.695 on 15 sales. Nonfat dry milk dropped half a penny to \$1.375 on 32 loads, and whey was gained \$0.0025 to \$0.6025 on 13 loads traded.

In futures markets Class III contracts average \$20.37/cwt. for October through March, while Class IV contracts average \$21.07 for the same six months.

Class I Mover

The November Class I Base price was announced to be \$22.53/cwt., down \$0.64 from the previous month.

Livestock Slaughter

210,400 dairy cows were culled in September, a 20,300 head decline from August 2024 and 30,100 lower than September 2023.

Milk Production Report

September milk production was reported to be 18.2 billion pounds, up 0.1% from the previous year. The U.S. dairy herd size was reported to be down 38,000 head to 9.3 million, this was more than offset by an increase in milk per cow to 1,950 pounds. August milk production was revised up 85 million pounds, meaning August production was actually up 0.4% and not down

California production remained relatively unchanged at 3.211 billion pounds, Wisconsin dropped 0.5% to 2.621 billion pounds, Idaho gained 1.8% to 1.398 billion pounds, Texas was up 4.9% to 1.395 billion pounds, and New York production increased 1.2% to 1.320 billion pounds.

Cold Storage

In Septen.ber, total natural cheese stocks in refrigerated warehouses were down 1% from the previous month and down 7% from the previous year. Butter stocks were down 7% from August 2024 but up 14% from a September 2023.
