DAIRY NEWS OF INTEREST

Market Update

Spot butter on the CME closed at \$2.97, up \$ 0.05 on 35 loads traded. Barrels soared to \$1.7725 jumping 11.25 cents on 9 loads, and blocks gained \$0.07 to \$1.75 on 3 loads traded. Nonfat dry milk lost \$0.01 at

In futures markets Class III contracts average \$17.90/cwt. for April through September, while Class IV contracts average \$20.52 for the same six months.

Dairy Margin Coverage 2024

The enrollment period for 2024 Dairy Margin Coverage is currently open and closes on Monday April 29th. A revision to the 2024 program allows eligible herds to make a one-time adjustment to established production history.

Livestock Slaughter

244,600 dairy cows were culled during March, 8,100 less than February and 61,600 fewer than March 2023.

Milk Production

On Monday the USDA reported March milk production to be 19.603 billion pounds, down 1% from a year ago. The U.S. dairy herd size was announced to be 9.335 million head, down 98,000 head from the prior year. Milk production per cow remained unchanged from the prior month at 2,100 pounds. California milk production experienced a 0.7% uptick, Wisconsin gained 1%, Texas dropped 5.1%, Idaho fell 1.3%, and New York slipped 0.2%. New Mexico lost 15.4% and had 20,000 fewer cows. South Dakota's impressive production climb continues with an 11.2% gain and 21,000 more cows.

February milk production was revised up 90 million pounds and down 12,000 head.

March Cold Storage

Total natural cheese stocks in refrigerated warehouses reached 1.459 billion pounds, up slightly from last month and down slightly from last year. Butter inventories totaled 316 million pounds, up 6% from February and 2% from last year.
