## Instructions for Completing Application For Transfer

THE RULES FOR THE REGISTRATION AND TRANSFER OF JERSEY CATTLE OF THE AMERICAN JERSEY CATTLE ASSOCIATION READ: "Every change in ownership of a registered animal or embryo shall be promptly recorded with the AJCA by the seller in order that progeny of the animal may be registered and subsequent changes in ownership recorded. In the case of a change in ownership of an animal or embryo where the seller has been paid in full, an application for the record of such change in ownership shall be immediately completed in every detail by the seller, including the new owner's name and date of sale, and must be promptly sent to the Association, together with the proper fee. Date of sale is defined as the date the buyer takes possession of the animal or embryo. ... Open transfers are condemned and declared to be a violation of the By-Laws and subject to disciplinary action of the Board of Directors. Failure to comply with this rule is a direct violation of the By-Laws of this Association. The AJCA looks to the seller for all transfer fees."

1. Write in the date of sale and the number and type of embryos sold.
2. Print name of buyer and write in the complete address. Print AJCA owner number, if known.

3. List the name and registration number of the donor dam and service sire. If mixed semen was used, also list the name of the second service sire. The donor dam and sire(s) must be parentage verified.

IMPORTANT: A donor dam may be inseminated with semen from more than one bull provided:

(1) All requests must be made at least three days before breeding the donor dam. (2) Donor dams must be parentage verified (with the results in the Association office) before any interpretations will be accepted. (3) All bulls considered must be parentage verified in the United States. All interpretations are provided in writing. (4) All progeny from ET recoveries using semen from more than one sire will be required to be parentage verified. The AJCA is not responsible or liable for progeny resulting from pooled semen; it is used at the risk of the breeder.

4. The seller must sign personally and give his/her complete mailing address or the correct owner number.
5. The Association's Bylaws require the seller to pay the transfer fee. Mail at time of sale for lowest fee. Please remit by check or money order. If cash is sent, register the letter. American Express, MasterCard, and Visa are also accepted.
